Dan began on Tuesdays and Thursdays and worked one-on-one with a job coach until he felt comfortable to do his job duties on his own. Before long the school was asking if Dan could come every day.

Dan not only keeps busy in the kitchen, but he also keeps the entertainment rolling with his witty personality at the Carroll Middle School. Once that first bell rings for lunch, the kids are off and there is no stopping them to fill their hungry appetites. It is in the midst of the chaotic screaming and sneakers squealing that you are greeted with Mr. Dan Owen's smile.

The next school year Dan was offered a full-time position as a Carroll Middle School employee working Monday through Friday helping serve food to students and cleaning dishes. Not only was the school pleased with him becoming a school employee, but so were the students and his co-workers. Nancy O'Brien, Kitchen Manager, stated "He is such a hard worker and always full of fun. The minute he walks in the door he has a smile on his face. When Dan isn't here, all of us ladies find ourselves missing him because he brings such an upbeat and positive energy."

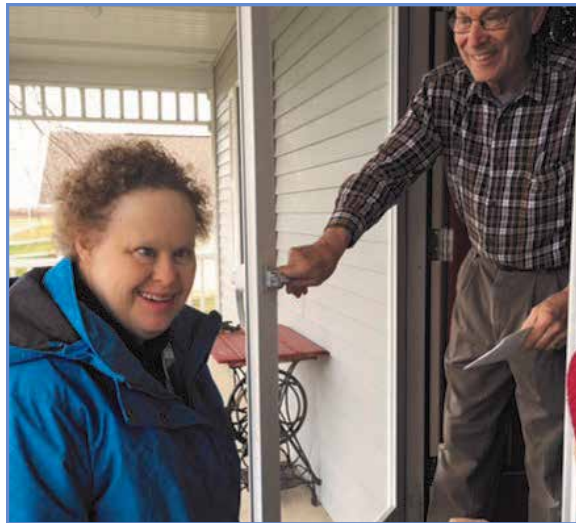
